

#### 1. CALL TO ORDER

J. Eby presided as chair for the Canadian Guernsey Association. The meeting was called to order at 1:26 pm with thirteen (13) members in attendance.

#### 2. ACCEPTANCE OF AGENDA

J. Eby asked for any additions or deletions to the agenda that was circulated.

On Motion by C. Comfort and seconded by B. Eby, it was RESOLVED THAT the Agenda be accepted as presented. Motion carried.

#### 3. APPROVAL OF MINUTES FROM PREVIOUS ANNUAL MEETING

J. Eby advised that the meeting minutes from Friday, March 18, 2022 Annual Meeting were in the Annual Report and provided highlights of the meeting. Action items from that meeting were noted, with an update on investments interest, correction on statistics from Ag Canada butterfat percentages and updates to website.

There being no errors or omissions noted, the Chair requested a Motion that the reading of these Minutes be dispensed with and that same be approved.

M. Bartlett accepted the previous minutes. P. MacLeod seconded. Motion carried.

#### 4. PRESIDENTS ADDRESS

J. Eby read his message as presented in annual report.

#### 5. ADMINISTRATION

E. Wallace read the administrative report as presented in the Annual Report.

#### 6. FINANCIAL REPORT

- J. Eby reviewed the 2021 and 2022 financials such as assets, liabilities and equities, market, losses, etc. J. Eby asked for a motion to accept the financial statement as printed. S. Gordon moved the motion. M. Bartlett seconded. **Motion carried.**
- J. Eby mentioned the acceptance letter from the Financial Review Committee. J. Eby asked for a motion to accept the committee's report. J. Forster moved the motion, P. MacLeod seconded. **Motion carried.**
- J. Eby presented the budget for 2023. Prediction of a \$6400 surplus this year. J. Eby asked for a motion to accept the budget. P. MacLeod moved the motion, which was seconded by C. Comfort. **Motion carried.**

#### 7. BREED IMPROVEMENT COMMITTEE

S. Gordon highlighted his report as presented in annual report.

Followed some discussion on how fees would work regarding genomic test project, process and fees.

S. Gordon reviewed the breed averages and statistics for previous years.

#### 8. FEILDMANS REPORT

R. Gammon highlighted his report from the annual report.

#### 9. PROPOSED BY-LAW AMENDMENTS

R. Gammon noted that twenty-two (22) amendments were submitted last year. Out of 22, nineteen (19) were approved and the remaining three (3) will be presented again at this meeting, 2 to bring forth with new wording and one to leave as is.

Following are the three (3) proposed by-law amendments that were presented.

#### 1.Be it resolved that Section 14 Recorded Animals page 11, which reads:

An animal which exhibits typical Guernsey characteristics, but for which there is no available information on its ancestry, shall be recorded at a level designated on the certificate as "Base-BB". An animal which does not exhibit Guernsey characteristics shall be recorded as "Crossbred-XX". This designation may apply to more than one generation, if those generations do not exhibit Guernsey characteristics or otherwise meet the requirements of Base or percentage animals. The progeny of Crossbred animal that exhibit typical Guernsey characteristics shall be recorded as Base-BB animals and the progeny that are out of a Base-BB dam and have a known purebred Guernsey sire shall be recorded as 50% Guernsey.

#### Be amended to read:

An animal which has Guernsey characteristics and there is no available information on its ancestry shall be recorded at a purity level designated on the certificate as 0%. Progeny may not be upgraded unless it exhibits typical characteristics of Guernsey. The progeny of Crossbred animal that exhibit typical Guernsey characteristics shall be recorded as 0% animals and the progeny that are out of a 0% dam and have a known purebred Guernsey sire shall be recorded as 50% Guernsey.

#### Reasoning:

Only one type of certificate needs to be issued which clearly states the purity level of the animal. Base-BB or Crossbred designations are no longer relevant.

On recommendation by the Canadian Guernsey Board of Directors, it was: RESOLVED that the By-Law be approved as presented to the meeting. **Motion carried.** 

#### 2.Be it resolved that Section 18 1a. TRANSFER AND DUPLICATE CERTIFICATES page 14, which reads:

An application for transfer of ownership of an animal or embryo must be completed showing the name of the actual purchaser and signed by the seller or their authorized representative, who shall pay the transfer fee. In the case of a female, the service certificate must be completed, or the application must be accompanied by the approval Artificial Insemination report. The application for transfer with the certificate of registration and fee must be forwarded to the Registrar for recording and endorsement of ownership.

#### Be amended to read:

Upon the sale of an embryo or animal as registered or purebred, it is a responsibility of the seller to ensure a duly transferred certificate, issued by the Association, is provided to the buyer within 6 months. A seller shall initiate the transaction by submitting a transfer in an approved manner with the Association and ensuring arrangements are complete for the payment of any necessary fees. In the event that the buyer and seller intend for a sale agreement to supersede this protocol, the responsibility for payment of the transfer fee and responsibility for submitting a transfer may be established amongst the parties themselves. In such case, proof of the buyer-seller agreement shall be made available to Guernsey Canada upon request. Old certificates of registry are destroyed if returned to office or should be destroyed by owner upon receipt of new certificate issued.

#### Reasoning:

Allows for electronic or multiple means for completing a transfer of an animal or embryo. The payment for the transfer fee will be decided on between buyer and seller before the transfer is completed and the association will automatically invoice the proper party.

On recommendation by the Canadian Guernsey Board of Directors, it was: RESOLVED that the by-law be approved as presented to the meeting. **Motion carried.** 

#### 3. Section 18.2. which reads as follows:

A duplicate certificate may be issued if the registered owner or their authorized agent files a statutory declaration on a form supplied by the Registrar showing in a satisfactory manner that the original is lost, destroyed or unobtainable, or a duplicate certificate may be issued if the application is certified by an official appointed by the Executive of the Canadian Guernsey Association.

#### No Change to this by-law.

**Rationale:** the issuing of duplicate certificates is governed by the procedural guidelines of the Association and not included in the by-laws. Proof of current and up to date animal information is available online therefore a statutory declaration is not necessary to reissue a Certificate of Registry.

APA Rationale: the issuance of duplicate certificates would fall under the provision of the Act. By-laws should therefore establish the general requirement(s) for re-issuance of a registration certificate.

On recommendation by the Canadian Guernsey Board of Directors, it was: RESOLVED that the by-law be approved as presented to the meeting. **Motion carried.** 

#### 10. AWARDS

P. MacLeod presented awards to members for each class.

#### 11. ELECTIONS

R. Gammon ran the elections. A. Spence stepped down. B. Comfort and R. Forster were elected to the board and accepted.

R. Gammon asked for a motion to accept. S. Gordon moved the motion. P. MacLeod seconded the motion.

#### 12. NEW / OTHER BUSINESS

None.

#### 13. ADJOURNMENT

J. Eby adjourned the meeting at 3:11 pm.

#### 14. CLOSING REMARKS

R. Gammon ran the auction. \$700 was raised. J. Eby thanked staff for organization of the Annual Meeting, Registrar for all her work and members for attending.

#### FIELDMAN'S REPORT



#### MOMENTS OF DECISION RE-DIRECTION

A hearty greeting to all those who are keen about and invested in the future of the Guernsey cow in Canada!

In a world where we are constantly in communication either live or over our phones digitally; our wisdom dictates that we regularly take time to stop and listen. Active listening bears much fruit as we ask questions to ensure we understand the other person.

I recently had the golden opportunity to visit with two newer owners – significant numbers of Guernseys! I learned so much from listening to them about their launch into the Guernsey breed and what they have learned and experienced since.

They shared that they really enjoy working with Guernseys because of their temperament. They have been able to manage their cattle to see milk yields of upwards of 9,000

to 13,000 kilograms of milk from their best producers, with good levels of milk solids. Both producers are fortunate to receive a bonus for a portion of their production, which is used for the creation of Guernsey-specific products. They've had solid success raising heifers. They did express mild concerns about reproductive efficiency of the breed. When identifying challenges with working with the breed they had an almost identically worded comment: "More Guernseys are needed. We need other source herds for animals if we are short on milk or have periodic challenges requiring the purchase of a few head." In both cases they would prefer to purchase Canadian stock and the more local the sources the better.

At this juncture we must ask ourselves which is the greater challenge? When demand for our product is meagre or non-existent or when you have abundant demand? The answer is obvious! However; the wrinkle comes into the obvious preferred scenario (hint: It is the latter one!) when you have much greater demand than you can fill.

Based on the goals for the breed for the near future endorsed by the CGA Board the clear target is growth of the Guernsey breed in Canada. It is never easy to identify the obstacles in obtaining that goal. On the other hand, true visionary leadership says: Okay, what are we going to do about this matter? What actions need to be taken? HOW can we know success in breed growth?

We've noted on numerous occasions that we receive a modest but steady demand for Guernseys as family/ acreage cows. Most of that interest comes from the Western Provinces where supply is thinner than Central and Eastern Canada, and by thin we mean very thin! This demand is a definite small sidebar to regular breed expansion work.



I would respectfully, but also fervently ask leaders of the breed and others who are passionate about the breed to address this topic with vigour and a controlled sense of urgency. It appears to be job #1 for the breed!

We see some exciting developments to celebrate and build upon:

- At least four highly prominent sales in the first half of 2024 are featuring at least one Guernsey consignment. These happenings provide opportunities for those who wish to purchase their first Guernsey, those looking for a quality 4-H project, those who want to add foundation stock to an established Guernsey grouping and the export market south of the border.
- CGA has a very active presence on social media, and we have good pick up to the material that we post. We must commend the World Guernsey Cattle Federation on their highly superb efforts to share positive Guernsey information, stories and images on the active "World Guernsey" Instagram pages. We draw quite a bit of material from that page and reuse it. In some sense the Guernsey breed is "punching above its weight" in this regard.
- How exciting it is to see 4-H members lining up Guernsey calves for project/club use and completing those projects.
- We so look forward to the Golden Guernsey Gathering Day on March 27th. This is an initiative glimmering with possibilities and potential. The hosts will be ready, and a great Golden Guernsey story will be available that day. Question: How do we effectively address the interest of anyone who is keen to invest in Guernsey genetics after that day?

- Further afield are the summer picnic and the National Show in Ancaster in September.
- Participation in the widespread genotyping project has been great so far and it is obvious that all allocated funding will be used. What are the next steps as follow up? What do we learn from this experience?
- As always, the question is: How can we do more, but more importantly, how can we marshal and use our resources to maximum effectiveness to create a more robust Guernsey presence in Canada?

Thanks to the board for your guidance, enthusiasm and input and ideas. Expressing enough gratitude to our administration and support staff is almost impossible. I could not begin to count the number of people I have told about the positive, wise, logical input from various members of the "Guernsey team at Holstein Canada". Linda has been our rock, and it is great to welcome Nicky back. They have several colleagues within the HQ in Brantford who have been ever so helpful and provided top quality support.

Together with vision, determination, more ideas that morph into action and positive attitudes we can get the job done, continually! Thanks so much for allowing me the privilege of being part of the evolving Golden Guernsey story in Canada!

## **Breed Improvement Committee Report**

Once again, it's time to reflect on the past year in the Guernsey breed. The Guernsey genomic testing program was the biggest development last year and has been well received. There have been 244 animals tested so far, 166 cows and 78 heifers, with some funding left. It's going to be interesting to see what information we can glean from the results.

There have been a few adjustments made to the classification system over the last year as well. Locomotion scoring has been implemented in the free stall barn category but is still a research trait for tie stall systems. To accommodate locomotion and Front Leg View slight adjustments have been made to the Foot and Mobility section on the scorecard. Other minor changes include the Teat Length Measurement which will now be done from the back teats instead of the front. Code 9 Rear Teats that are too close will result in an automatic defect and 2-point deduction off the mammary score. Also, the term Dairy Capacity has been changed to Rib Structure.

The committee looked over the classification reports and it appears the change we made to the Rear Udder Height measurement 2 years ago is having the desired effect. High Tail Head is again the defect that gets the most attention

from the classifiers, but Toes Out Front was also identified on a high number of cows last round. We will need to monitor this now that a Front Leg View has been introduced. Another research trait being measured in herds now is the Anogenital Distance. Researchers have found a relationship with this measurement and fertility so it will be interesting to see if this can help the Guernsey breed.

I have also been in contact with the classification coordinator, Bruno Jubinville, asking if he could try to plan the classifiers yearly workshop at a farm with Guernsey's to try to build up their familiarity with our golden breed.

Lastly, after about a dozen years as chair of the Breed Improvement Committee it is time for me to step back and let someone else lead the committee into the future. I'd like to thank the committee members and our administrators for all their support over the years. It has been an honour to serve the breed in this capacity.
