Prepping for the Future!

A common expression in society today is: "Chillin' Like a Villian". In the Guernsey breed there is zero time for such frivolity. Our members work hard and need and deserve a true break from time to time. However; as an Association we must be constantly striving to place more emphasis on doing more of the right things than just being busy and ever chasing the do more mantra!

That being said there are definite signs that something (beyond good) is happening in the Guernsey realm in Canada!

The oomph and spring in our step both increased markedly with receipt of 2024 year-end stats from your Administrative Dream team at HAC at Brantford! We suspect that many Associations would very much want to be able to say that their 2024 annual memberships are the highest they have been in a quarter century, since 1999! Think about it: CGA ACTIVE ANNUAL MEMBERSHIPS ARE AT THE HIGHEST LEVEL THEY HAVE BEEN AT IN THE FIRST QUARTER OF THIS CENTURY! Definite cause for a pause to rejoice!

When you add this to the fact that registrations were at their highest level since 2003 in 2024 joy abounds! Think about that! **TWENTY-ONE YEARS SINCE A HIGHER REGISTRATION LEVEL!** Celebrate good times, come on, yeah, as a famed song says!

While annual memberships are currently at a level set as a goal by the CGA Board a few years back there is so much more room for growth and indeed, so much NEED for more growth in the number of people owning and working well with Guernsey's in this large country. May we also say more dairy producers expanding Guernsey numbers through using the best possible bulls available and using a lot of sexed semen! Plus, more folks doing ET and IVF work and implanting embryos in other breeds or selling embryos to folks with non-Guernsey recipients. So much more growth is possible. There is no question that markets would be available to fill if there were more Guernsey's available! We have a steady stream of demand for the bovine part of our product line, we need animals to fill it! The other factor is that while our membership total is healthy and growing the registration total is well off of the goal set by the Board for this measure. We urge our leadership and the pool of Guernsey owners across the land to discuss this necessary topic, land on solutions and implement those solutions.

How exciting it has been to see the growth of genomic testing, largely through the most excellent program established by CGA, within this breed. More numbers growth will come from adding results from older animals that were DNA tested but not yet genomic tested. We are sure the 500 samples tested mark will be exceeded in 2025 but why slow down!? Time to go all in and all gas, no breaks on this effort too! Canada is becoming known as a leader in this realm. A big bow to previous Boards and staff who have done a TRULY SUPERB job of managing finances with care but also vision. Unlike some sister associations CGA is in a sound financial position. This allows for wise investment of reserves to keep growing the breed!

We have worked hard to raise the visibility of the Guernsey breed in Guernsey circles and beyond. How? **990**Facebook posts during 2024. In the first two months of February 2025 up to the morning of February 27th an additional **240** posts have been made. This brings that fourteen-month total, to date, to **1,230 posts!** We have climbed from somewhere around the 3,000 followers level, a few years ago, to an approximate level of **6,220 followers!** It is conceivable that the number could grow to more than 7,000 by the end of 2025! We cannot thank the World Guernsey Cattle Federation, Global Guernsey Marketing and the great folks at the American Guernsey Association for all the material they share which we can share. The WGCF input comes mainly from the Federation's very active Instagram account!

As with everything else we must constantly ask: How can we be more effective? How can we do a better job? How can be encourage more dairy producers to be actively engaged with all of exciting activity in the Guernsey breed!??

CGA does a superb job encouraging 4-H members. Those dedicated 4-H members do an exceptional job keeping Guernsey's in front of the agricultural public! So great that CGA supported the three teams who had Guernsey members participating in the amazing TD 4-H Dairy Classic this year! Further that CGA recognizes 4-H members completing a year's worth of effort with Guernsey calves!

Our National Show each September is an excellent showcase for the breed. Ancaster Fair are great hosts. We obtain super mileage from the excellent photographs taken there! Exciting to see Canadian Guernsey's exhibited at Madison and WDE this year with some sold there! Tip of the Guernsey hat to London Dairy and Co for their efforts and buying animals to bolster their string. Nice to see Treat from Maplehurst (originally) doing well.

In 2025 there will be a Guernsey heifer from London Dairy, wearing the Maplehurst prefix in the very high-profile Calves for a Cause sale! The 2024 Guernsey sold well and represented the breed admirably! Let's support the 2025 calf!

On the horizon is the 2026 World Conference in Australia. We already know of one or two Canadians who will be attending! Australia is a stunning country. The entire event, spread across a number of states, will be super-terrific!

The Golden Guernsey Gathering in March and the Summer Picnic in July afforded superb opportunities to gather Guernsey-convinced folks and those considering the breed together to learn more about this amazing breed and her very high-quality milk. Thanks to our generous hosts!

In the end dairy cattle are "all about the milk" and about the products processed from that milk. Markets for Guernsey milk-fluid and further processing milk, are expanding. This leads back to the need to expand the female population of Guernsey's in this country. The efforts of cheese factories and Guernsey owners to create extremely high-quality milk products and make them available are grand, simply grand, as the Irish would say! There is some terrific work being done in Ontario and British Columbia! Kudos to Eby Manor and suppliers, Upper Canada Cheese and the Comforts and Promise Valley. It is possible a new face in this realm will appear in 2025 or 2026!

It is time to keep going, to strive wisely and to be swept up in the enthusiasm surrounding Guernsey cattle, Guernsey people and Golden Guernsey milk!

The efforts by our admin team in Brantford and their HAC associates are nothing short of terrific! What a golden relationship we enjoy! Hats off to y'all too!

Breed Improvement Committee Report

Looking Back on 2024:

The year 2024 was primarily focused on increasing the number of genomic-tested Canadian Guernsey animals. We kicked off the year with a presentation at the 2024 AGM, where our guest speaker, Brian Van Doormaal, provided an insightful "Genetics Overview of the Canadian Guernsey Breed."

"Gradually, over time, a full commitment by all Canadian Guernsey breeders to genotype 100% their registered heifers will translate to a greater gain in accuracy of genomic evaluations ... and a faster rate of genetic progress for the breed!" – May Guernsey News issue – Lactanet Article -Maximizing Genetic Progress in Canadian Guernseys

Throughout the year, our committee received invaluable guidance and support from Lactanet, particularly on genotyping of older AI bulls and enhancing the testing of the current active population. We continued to see growth in the number of genomic animals tested, largely due to the genotyping program introduced by the CGA Board. This initiative offers partial or full coverage of test fees for herd owners participating in genetic improvement programs.

As we closed out 2024, we began a new project aimed at obtaining stored microsatellite samples from animals tested prior to SNP testing and subsequently testing them. Expanding the reference population of genotyped animals will accelerate genetic progress and help ensure the long-term sustainability of the Guernsey breed.

The summer picnic at Comfort Farms featured a Classification presentation by Dave Weitzel, offering a helpful review of the reference points used in evaluating our cows.

Looking ahead to 2025, our Committee will focus on reviewing the classification reports, the Star Brood Program, and the Gold Star and Master Breeder member awards.

In closing, let's continue working to increase the reliability of genomic evaluations. A heartfelt thank you to the Breed Improvement Committee members for your support throughout the past year






